# Drafting of the NAP 2016 – 2020

 Call to Action - "Caribbean Workshop to Develop National Action Plans on Antimicrobial Resistance" being held at the Trinidad Hilton and Conference Centre, Port of Spain, Trinidad and Tobago from 11 to 13 October 2016. Tripartite approach – WHO/PAHO, FAO, OIE.

 Mandate was collaboration of Ministries of Health, Agriculture and Research in the drafting of official document which outlines the activities that the government will carry out to meet its main objective

 To combat AMR in Jamaica through united and multisectoral one health approach.

# National Action Plan


- Technical Team comprised of multidisciplinary and expertise team - Veterinarians, Food Safety Specialist, Public Health Specialist, Veterinary and Medical Epidemiologists, Microbiologist, Biochemical Analysist, Plant Researchers, pharmacist, Environmentalist
- Every Thursday, fours years and two major workshops, fifteen members from the Ministries of Agriculture and Fisheries, Health and Wellness, Economic Growth and Job Creation, University of the West Indies(Research) - hosted by the PAHO Jamaica office.

Strategy 4 – Optimize appropriate Antimicrobial Use of medicines in human and Agriculture health

Strategy 5 – Strengthen Legislation/regulatory framework for AMU/AMR

Use the WHO template – Five-year Operational plan and Costing with Funding sources

# The outputs of the costing exercise

Awareness of an excellent and user-friendly tool - User Guide, Training PPTs, Training videos, AMR resource materials, Help desk

Knowledge - step by step approach— NAP entry, Basic inputs for tools, Building block for each selected strategic objective, Funding inputs, Dashboard, Funding Dashboard

Five Persons Trained - Opportunity for collaboration and Capacity building – local and international partners and Technical and Accountants personnel working together

Released of this tool – perfect timing –drafting of AMR Monitoring and Surveillance programme for Agri-food chain(Livestock).

### Lessons Learned

Cost and Budgeting tool is critical part of NAP development process

Cost will be in your country's currency or in the donor's

The tool should be introduced from the beginning

Technical, Programme managers and Accountants should work together

NAP – prioritized activities and identify main areas that would need costing of every activity –

Tool provided specific, focused actions that must have a cost – venue, target audience, number of persons, consultants....

#### Lessons Learned

Maintain the momentum by using the tool with the NAP activities

Tool can be used to along with Ministry's budgeting cycle and five-year plan

Each strategic plan objective can be cost and budget as "projects"

The Dashboard can be used to assist in monitoring plans

Aligned existing programmes with the NAP activities

Challenge – COVID-19/same staff - designed staff for AMR
