Report of the Third Inter-Sessional Meeting of the Review Committee on the Role of the International Health Regulations (2005) in the Ebola Outbreak and Response

ORGANIZATION AND PROCESS OF THE MEETING

- 1. The third inter-sessional meeting of the Review Committee took place at WHO headquarters in Geneva, 9-11 December 2015, with the following agenda:
 - 1. Welcome and introduction
 - 2. Reports from the Review Committee sub-groups
 - 3. Interviews with informants
 - 4. Review Committee deliberative sessions
 - 5. Open Session via webcast and in-person

SUMMARY OF INTERVIEWS

2. The Review Committee interviewed informants by telephone (except where indicated) on 9 December 2015 (see Annex 2 for names and affiliations of informants). Annex 2 also lists informants who were interviewed by members of the Review Committee during the inter-sessional period following its 9-13 November 2015 meeting.

SUMMARY OF DELIBERATIVE SESSIONS

- 3. During its deliberative sessions, the Review Committee reviewed the findings of the three sub-groups which were tasked with developing draft recommendations based on eleven previously identified challenges to the implementation of the IHR. The Committee discussed and refined these recommendations into four major areas: 1) increasing awareness and institutionalisation of the IHR among all stakeholders; 2) improving global public health risk surveillance, assessment and response; 3) strengthening IHR core capacities, in all contexts, through prioritisation, cooperation, evaluation and accountability; and 4) strengthening the WHO Secretariat in its priority mission concerning IHR implementation and in its partnerships for reinforced global public health security. The Committee also continued its assessment of the effectiveness of the IHR as related to the Ebola outbreak and the status of implementation of recommendations of the previous Review Committee in 2011.
- 4. The Committee agreed on a plan for the drafting and review of its final report.

- 5. The Chair proposed a schedule and plan of organization for the remainder of the Committee's work. The Committee will continue in deliberative sessions during a fourth inter-sessional meeting to be held 10-12 February 2016 in Geneva. In the inter-sessional periods the Committee will continue its work through teleconference and electronic exchange.
- 6. A progress report will be presented to the Executive Board in January 2016. The Review Committee plans to present a final report to the Sixty-ninth World Health Assembly in May 2016.

OPEN SESSION

- 7. An open session was held in-person and via webcast on the afternoon of the final day of the meeting. The Chair of the Committee presented a summary of its current work and processes and outlined the direction of its future work. The Chair invited comments and questions from representatives of States Parties, the United Nations and its specialized agencies, and other relevant intergovernmental organizations and nongovernmental organizations in official relations with WHO.
- 8. The Committee discussed and endorsed the meeting report.
