1. Updated registration numbers and our goal for 5 May 2013

The updated numbers of facilities registered for SAVE LIVES: Clean Your Hands, as of 11 March 2013, are the following: 15 423 facilities from 161 countries, corresponding to more than 3.8 mio beds and almost 9 mio health-care workers*.

We still need a lot of help to achieve our goal for 5 May 2013!

By 5 May 2013, please help us achieve new registrations from at least 5 new countries that have NO facilities yet registered, especially in the



African Region, and to increase registrations in countries with low numbers!

2. Remember that patients have a voice too!

We have been informed that many national campaigns have picked up on our call and are getting ready to celebrate 5 May with a special focus on patient participation in hand hygiene promotion! This is fantastic! If you are not aware, see if there is a campaign in your country and seek information about national support, activities and plans for 5 May celebrations! Among WHO tools posted on the WHO web page dedicated to patient participation in hand hygiene promotion, we would like to highlight the document entitled "Guidance on Engaging Patients and Patient Organizations in Hand Hygiene Initiatives". This is very comprehensive guidance to understand patient empowerment, to facilitate ownership and shared responsibilities, and to develop your programme taking into account your local context. We believe that this document could help you a lot!

This month we are also pleased to offer you a **NEW TOOL** called "<u>Tips for implementing a successful patient participation programme</u>". It has been developed thanks to the experienced advice and input of reknown experts on this topic: Dr Maryanne McGugkin (McGuckin Methods International, USA) and Dr Yves Longtin (University of Quebec, Canada). We hope that it represents an easy checklist for you to identify and implement essential elements in your patient participation programme! This document also highlights a list of papers providing good examples of patient participation programmes, looking at implementation as well as an overview of barriers, solutions and strategies for both HCWs and patient participation/empowerment.

On 6 March, our two experts cited above delivered a very insightful presentation entitled "Patient participation in hand hygiene promotion and improvement – PRO and CONS" within our 2013 Free Teleclass Series on Infection Control, run through Webber Training. 3. Hand hygiene monitoring and feedback

Heading to 5 May, use or reuse the <u>WHO Hand Hygiene Self-Assessment Framework (HHSAF)</u> to get a situation analysis and track progress at your facility! After completing the HHSAF, use and adapt the <u>WHO Template Action Plans</u> to implement your plans for local improvement! Select one action to target for 5 May 2013!

Continue to regularly look at our page dedicated to hand hygiene monitoring and feedback! In April, we will be providing a summary of the scientific literature on the automatic/electronic monitoring of hand hygiene indicators.

4. 2013 Free Teleclass Series on Infection Control

To support our call to action for 5 May 2013 on monitoring and feedback, Dr John Boyce (New Haven, USA) will make a presentation on "Innovation and new indicators in hand hygiene monitoring". This teleclass will take place on **9 April 2013 at 1.30 pm (NYT)** and will be kindly chaired by Dr Hugo Sax. Go on, Register now!

5. ICPIC abstract submission deadline approaching! The abstract deadline of the second International Conference on Prevention and Infection Control (ICPIC) is only 9 days away, on 22 March 2013! Please be reminded that submitting a high-quality abstract will be an essential criterion in being selected for travel fellowships and grants for participants from low- and middle/income countries.
