Background

Launched in 2019, the World Hearing Forum is a global network of stakeholders promoting ear and hearing care worldwide. Members of this advocacy network will commit to facilitating implementation of World Health Assembly resolution <u>WHA70.13 on "Prevention of deafness and hearing loss"</u> and the *World report on hearing*.

Purpose of the forum:

The World Hearing Forum is filling a critical gap by bringing a collective vision to advocacy and collaboration in this field. Through networking and by sharing knowledge, skills and experiences from the field, the World Hearing Forum is galvanizing action towards a world in which no person experiences hearing loss due to preventable causes and those with hearing loss can achieve their full potential through early identification and appropriate management of their condition.

Activities of the forum:

The forum's activities currently focus on the following workstreams:

- 1. Changemakers
- 2. External relations
- 3. Make listening safe
- 4. Member engagement
- 5. World hearing day



World Hearing Forum stakeholders' meeting: recap

27 November 2023

The World Hearing forum opened with opening remarks from WHO's Assistant Director General, Professor Jerome Salomon and was chaired by Dr Alarcos Cieza, Unit Head in the Department for Noncommunicable Diseases, Rehabilitation and Disability. This was followed by Shari Eberts who shared her own hearing loss journey and how it was shaped by societal



perceptions. Dr Shelly Chadha set the stage for the meeting by providing the context about the relevance of changing perceptions of hearing loss within the society and among health care providers.

"Changing mindsets is essential to making ear and hearing care a reality for all" – Dr Shelly Chadha

Following this, Imre Hollo moderated a panel on societal perceptions of hearing loss with a diverse group of panelists representing different sections of the society:

- Ms Ketevani Kalandze (Georgia Parents Group),
- Ms Charmaine Sylvan (Caribbean Visionary Educators, Trinidad Parent-Teachers Association),



- Ms Joyce Nalugya (Global Coalition of Parents of Children who are Deaf or Hard of Hearing),
- Dr Premikha M (WHO Interns association),
- Mr Maurizio Arseni (Geneva Solutions), and
- Mr Brian Lamb (Hearing Loss and Deaf Alliance).

Each of these panelists offered their perspective on hearing loss and the associated societal stigma. Subsequently, Dr Lauren Dillard and Dr Pallavi Mishra (WHO) presented their findings of a systematic scoping review on perceptions and stigma regarding hearing loss.



Following the lunch break, Dr Carolina Der gave an overview about WHO advocacy tools and initiatives and how they can be used to facilitate actions to change societal perceptions. This was followed by presentations on specific advocacy tools and initiatives including World Hearing Day (Dr James Saunders and Dr Arun Agarwal), 'Amplifying Changemakers' stories' (Dr Rachael Hapunda and Ms Audra Renyi), and the 'Make Listening Safe' initiative (Dr Amarilis Melendez and Dr Mark Laureyns).

Split up into groups, the participants then worked to explore key barriers and actions to change mindsets related to ear and hearing problems through the following questions:

- 1. What are the key barriers to addressing societal perceptions of hearing loss (and ear problems)?
- 2. Outline approaches/actions that can help us change mindsets related to ear and hearing care problems?







Group work outcomes

Several key barriers and actions were discussed across each of the groups.

Below noted is a compiled list of the responses to the two questions from the various groups:

Key barriers to addressing societal perceptions of hearing loss (and ear problems):

- 1. **Invisibility:** Hearing loss and ear problems are often invisible and underestimated due to diverse range of problems, posing challenges for effective advocacy.
- 2. **Stigma and misperceptions:** Stigma and ignorance surround hearing loss, **fueled by cultural**, religious, and social misconceptions.
- 3. Lack of awareness: Limited awareness among parents, the public, healthcare staff, and policymakers contributes to a lack of understanding.
- 4. **Systemic issues and negative perceptions:** Issues include insufficient coverage of hearing loss in medical curricula, negative connotations, a lack of representation in the media, aesthetic concerns with hearing aids, inadequate healthcare system investment, negative perceptions of audiologists, and a lack of self-acceptance among individuals with hearing loss.

Approaches/actions that can help us change mindsets related to ear and hearing care problems:

- Promote Inclusive Environments: Advocate for accessible spaces and features.
- Empower Public Awareness: Educate the community about hearing loss prevention and management.
- Transform Educational Practices: Sensitize educators and integrate hearing health education into curricula.
- Foster Collaborative Advocacy: Partner with stakeholders to advance early hearing care practices and policies.
- Invest in Professional Training: Enhance the expertise of healthcare professionals in ear and hearing care.
- Guide Policy Development: Advocate for the adoption of global guidelines for hearing loss prevention and management.

28 November 2023

On day 2, the meeting reopened with a presentation by Dr Shelly Chadha and Dr Carolina Der on integration of ear and hearing care across the life course and available WHO tools to support this. This was followed by a panel discussion on healthcare provider perceptions related to hearing care moderated by Dr Amelia Tuipulotu, Chief Nursing Officer, WHO. The panel of experts who shared their valuable perspectives included:

- Dr Elisabeth Mukendi (World Federation of Public Health Associations)
- Dr Karine Lavoie (International Council of Nurses)
- Dr Antonio Rizzoli-Cordoba (International Paediatric Association)
- Dr Leon Geffen (World Organization of Family Doctors)
- Mr Salman Khan (International Federation of Medical Students Associations)



Mr Glenn Van Biesen, policy officer at the Belgian National Institute for Health and Disability Insurance provided the perspective of policymakers during a fireside chat with Dr Gerard Schmets. They discussed the motivations for integrating hearing care into national health policy., barriers and possible ways to address these.



To energize participants during the intense discussions, Dr Alarcos Cieza led the participants in doing the traditional 'COCONUT'. This activity involves standing up and spelling out the word 'coconut' with your arms. It's a great way to get your blood flowing and your energy level up!

During the afternoon session the participants were split up into groups to discuss ways for broadening the reach of the World Hearing Forum by considering two questions:



- 1. Which stakeholder groups, outside of EHC (professional and civil society groups), should we reach out to?
- 2. How can we motivate them to become ambassadors for integration of EHC?

Group work outcomes

Several stakeholder groups to reach out to were identified by the groups. In addition, they came up with various actions to be taken to motivate them to become ambassadors for integration of EHC.

Below, a summarized list of these can be found followed by a more comprehensive list.

Stakeholder groups, outside of EHC (professional and civil society groups), to reach out to:

- Healthcare workers: mental health professionals, pediatricians, geriatricians, nurses, general physicians, social workers, speech-language pathologists, pharmacists
- Government: Ministry of health, ministry of higher education, etc.
- Academic/Educational: Universities, parent and teacher associations, school boards, youth groups
- Industry: Toy manufacturers, film and music producers, video game developers
- Humanitarian: Rights-based organizations, foundations and funding groups
- Media: Social media influencers, media outlets, celebrities
- Advocacy: Public health organizations, local government workers, community organizations,
 patient advocacy groups, associations for the elderly

How to motivate stakeholder groups, outside of EHC (professional and civil society groups) to become ambassadors for EHC:

- Disseminate Information: Engage with relevant hearing care and non-hearing care stakeholders, including other health professionals, schools, and parent groups.
- Amplify Stories of Success: Collaborate with media, influencers, and stakeholders to share personal experiences and success stories of EHC.

- Develop Resources and Foster Engagement: Create relatable toolkits/packets for stakeholder groups and encourage participation in World Hearing Day activities.
- Promote Educational Initiatives: Advocate for universities to offer EHC education and support initiatives for hearing loss awareness among pupils, teachers, and parents.
- Leverage Youth and Disability Advocacy: Educate youth groups on hearing care inclusion and encourage disability organizations to advocate with policymakers.

World Hearing Forum members' meeting: 29 November 2023

The third day of the meeting was dedicated for members of the forum, which opened with some reflections from the members. Following this, each workstream's co-chairs had the opportunity to give a presentation on their group's activities and achievements over the past four years.



WHO thanked each of the outgoing Steering Committee members and presented them

with a memento to demonstrate WHO's gratitude for the great work they did. This was marked as an official passing of the baton ceremony to the new steering committee.









The incoming Steering Committee was welcomed and presented with the traditional WHO scarves.



During the remainder of the morning, the two new cross-cutting workstreams were introduced. These new workstreams will focus on 'external relations' and 'member engagement'. These along with the existing 'World Hearing Day', 'Make listening safe', and 'Changemakers' will make up the five workstreams of the World Hearing Forum.





The afternoon session was dedicated to the convening of these five workstreams who met in smaller groups to discuss their workplans.

These meetings provided an opportunity to the new co-chairs to formally introduce themselves to the workstream members and to begin working on each workstream's objectives. Following this, the groups returned to the main meeting room for a plenary discussion and a focus on the World Hearing Forum's next steps.
