

Pandemic Influenza Preparedness (PIP) Framework Partnership Contribution (PC) Recipient Countries 2020-21

The Pandemic Influenza Preparedness (PIP) Framework is a multi-faceted instrument that aims to improve global pandemic influenza preparedness and response. All countries are called upon in one capacity or another, to cooperate in, and contribute to, the efficient, effective and sustainable achievement of the objectives of the Framework.

The PIP Partnership Contribution (PIP PC) funds are used to improve preparedness through global, regional and country-level activities. Some countries are supported through (a) biennial country-specific work plans, and others through (b) activities implemented by WHO Regional and Headquarter offices. The criteria and process for prioritizing and selecting countries that will have country-specific work plans are outlined in the High Level Implementation Plan II, Section 5: *Selecting PC Recipient Countries*.

The Tables below provide the list of countries selected, by Region and Output, for country-specific work plans in the 2020-21 biennium. For Outputs not listed, country support is provided through the Regional or Headquarters work plans.
