Bidders are, therefore, requested to propose the best and most cost-effective solution to meet WHO requirements, while ensuring a high level of service.

1. Requirements

WHO may, at its own discretion, extend the closing date for the submission of proposals by notifying all bidders thereof in writing before the above closing date and time.

Any proposal received by WHO after the closing date for submission of proposals may be rejected. Bidders are therefore advised to ensure that they have taken all steps to submit their proposals in advance of the above closing date and time.

The offer outlined in the proposal must be valid for a minimum period of 90 calendar days after the closing date. A proposal valid for a shorter period may be rejected by WHO. In exceptional circumstances, WHO may solicit the bidder's consent to an extension of the period of validity. The request and the responses thereto shall be made in writing. Any bidder granting such an extension will not, however, be permitted to otherwise modify its proposal.

The bidder may withdraw its proposal any time after the proposal's submission and before the above mentioned closing date, provided that written notice of the withdrawal is received by WHO at the email address indicated above, before the closing date for submission of proposals.

No proposal may be modified after its submission, unless WHO has issued an amendment to the RFP allowing such modifications.

No proposal may be withdrawn in the interval between the closing date and the expiration of the period of proposal validity specified by the bidder in the proposal (subject always to the minimum period of validity referred to above).

WHO may, at any time before the closing date, for any reason, whether on its own initiative or in response to a clarification requested by a (prospective) bidder, modify the RFP by written amendment. Amendments could, <u>interalia</u>, include modification of the project scope or requirements, the project timeline expectations and/or extension of the closing date for submission.

All prospective bidders that have received the RFP will be notified in writing of all amendments to the RFP and will, where applicable, be invited to amend their proposal accordingly.

4. Evaluation

Before conducting the technical and financial evaluation of the proposals received, WHO will perform a preliminary examination of these proposals to determine whether they are complete, whether any computational errors have been made, whether the documents have been properly signed, and whether the proposals are generally in order. Proposals which are not in order as aforesaid may be rejected.

The evaluation panel will evaluate the technical merits of all the proposals which have passed the preliminary examination of proposals based on the following weighting:

The final evaluation will combine the weighted scores of both technical and financial proposals to come up with a cumulative total score.

Please note that WHO is not bound to select any bidder and may reject all proposals. Furthermore, since a contract would be awarded in respect of the proposal which is considered most responsive to the needs of the project concerned, due consideration being given to WHO's general principles, including the principle of best value for money, WHO does not bind itself in any way to select the bidder offering the lowest price.

WHO may, at its discretion, ask any bidder for clarification of any part of its proposal. The request for clarification and the response shall be in writing. No change in price or substance of the proposal shall be sought, offered or permitted during this exchange.

5. Award

WHO reserves the right to:

- a) Award the contract to a bidder of its choice, even if its bid is not the lowest;

Annex 1: Detailed Terms of Reference

Purpose of the APW

The purpose of this APW is to provide support to the Directorate General of Health Services (DGHS), Government of Bangladesh, to expand the activities of the model of post-crash response initiatives, which is currently operationalized by DGHS at 10 KM stretches of national highway, through an expert organization. The initiative is in alignment with safe system approach of the UN's Global Plan - Decade of Action for Road Safety and SDG Goal 3.6, which relates to reducing the number of deaths and injuries from road traffic injuries.

2. Background

Road traffic injuries have emerged as a worrying public health problem in Bangladesh. As per the WHO Global Status Report on Road Safety 2023, an estimated 31,578 people lost their lives in 2021 due to road traffic injuries in Bangladesh. According to a national survey in 2016, Two-thirds of all road traffic fatalities occur on the way to the hospital, and three-fourths do not receive any form of pre-hospital care. Considering the situation, the Non-communicable Disease Control Program (NCDC) of the Directorate General of Health Services (DGHS), with technical support from WHO and financial support from UN Road Safety Fund, developed a strategy with costed action plan which is awaiting for endorsement from the Ministry of Health and Family Welfare, protocols for the stakeholders to manange road crash injury victims, training manual for the first responders and piloted a post-crash response model at 10 KM stretches of Dhaka-Chattogram national highway from October 2021- March 2023 to strengthen the post crash response initiatives. An expert organization has been supporting NCDC-DGHS to continue its operation in the field for the last year. Stakeholders, policymakers, and local healthcare providers are well engaged in continuing the pilot model. NCDC-DGHS incorporated this initiative into their fifth sector operational plan and planned to extend the initiatives to the other parts of the highways with the support of developmental partners. Therefore, it is necessary to support DGHS in scaling up the post-crash response activities to sustain the initiatives in a manner where the government can independently operationalize this nationwide.

3. Planned timelines (subject to confirmation)

The Contractual Partner will be required to complete the activity within six months from the date of signing the contract.

Total duration: Six months (Tentative Start Date: 01 July 2024)

4. Requirements - Work to be performed

General Objective:

To scale up the post-crash response model in Bangladesh that can save the lives of the victims of road crashes.

Specific Objectives:

- 1. Evaluate the activities of post crash response phase 1 for lessons learnt and planning ahead.
- 2. Extension of the post-crash response model based on lessons learned.
- 3. Strengthen the system of road crash injury victims' transportation and management at Primary Health Care (PHC) settings.

5. Terms of references:

In consultation with the officials of the NCDC-DGHS, relevant stakeholders and Technical Officers of the World Health Organization, the contractual partner will:

A. Evaluate the activities of phase one of post crash response by:

- Visiting the project pilot area and meeting with the relevant stakeholders to understand the operational activities of the model from the field site.
- Developing an evaluation tool based on the discussion with relevant stakeholders, NCDC-DGHS and WHO.
- Monitoring the activities of the piloting site (Gazaria) with the support of trained volunteers, local stakeholders and NCDC-DGHS.
- Prepare an evaluation report of phase 1 of the post crash response model with recommendations to scale up and submit it to the government.

B. Extension of the activities of post-crash response model based on the lesson learned from phase 1 to provide emergency care of the victims of road traffic injuries in Bangladesh by:

- Developing standard operating procedures (SOPs) for the health facility manager to operationalize post-crash response initiatives from health facilities;
- Selecting extended project areas and primary health care facilities in consultation with NCDC- DGHS, WHO and relevant stakeholders;
- Ensuring multisectoral engagement for sustained success of the interventions
- Recruiting seventy local first responders in consultation with PHC facility managers situated in the project area;
- Engaging selected project area community members, local stakeholders through awareness campaigns and advocacy meetings;
- Organizing and facilitating training with the selected first responders, primary health care providers and other
 relevant personnel using the training manual developed by the NCDC DGHS for post-crash response, in close
 coordination with local authorities.
- Supplying required logistics, equipment and consumables to volunteers to operationalize the system (Logistics list is attached in annex 10)
- Arranging advocacy meetings with health care providers of the selected PHC facilities to update them about
 international best practices/protocols to manage road crash injury victims from their facilities and quarterly
 coordination meetings with stakeholders at the district or sub-district level to update the progress of the
 initiatives:
- Drafting all the meeting minutes/notes for records and get them endorsed by the relevant authorities;
- Developing a system to interlink between set emergency hotline number (16465) and the national hotline system (999).
- Developing a system to merge road crash data into the national Health Information System (HIS);
- Operationalizing the system and handing it over to local authority;
- Prepare and submission of the project end report with recommendations on scaling up the model nationwide to the government at the end of the project.

C. Develop a structured mechanism for road crash injury victims' transportation and ensure required management at primary health care settings by:

 Developing SOPs for road crash injury victims' transportation from the crash scene to PHC facilities and referral to the specialized hospital by expert consultation and submission to the Ministry of Health and Family Welfare (MoHFW) for endorsement.

- Developing a community working group on post crash response, including local stakeholders and relevant government officials, to reimburse the cost of treatment and transportation for road crash injury victims from government funds;
- Conducting advocacy meetings with the community group to strengthen the coordination for supporting post crash response model initiatives from their community;
- Drafting all the meeting minutes/Note for records and get them endorsed by the relevant authorities.
- Prepare and submission of the progress report with recommendations to the government to strengthen the road crash injury victims' transportation and ensure required management from the PHC facilities at the end of the project.

6. Delivarables:

A project completion report with description of project initiation, operationalization, challenges, and recommendations to the Government on scaling up the model nationwide, and management of victims of road traffic injuries at primary health care settings in a sustainable way.

7. Expected Outcomes:

Post-crash response model operationalized in other parts of the national highways, and a road map of road crash injury response developed to ensure the emergency care of road crash injury victims within the golden hour.

Annex 4: Contractual Provisions

Within 30 days of receipt of the contract between WHO and the successful bidder (the "Contract"), the successful bidder shall sign and date the Contract and return it to WHO according to the instructions provided at that time. If the bidder does not accept the Contract terms without changes, then WHO has the right not to proceed with the selected bidder and instead contract with another bidder of its choice. The Contract will include, without limitation, the provisions set forth below (with the successful bidder referred to below as the "Contractor"):

1. <u>Compliance with WHO Codes and Policies</u>. By entering into the Contract, the Contractor acknowledges that it has read, and hereby accepts and agrees to comply with, the WHO Policies (as defined below). In connection with the foregoing, the Contractor shall take appropriate measures to prevent and respond to any violations of the standards of conduct, as described in the WHO Policies, by its employees and any other natural or legal persons engaged or otherwise utilized to perform any services under the Contract.

Without limiting the foregoing, the Contractor shall promptly report to WHO, in accordance with the terms of the applicable WHO Policies, any actual or suspected violations of any WHO Policies of which the Contractor becomes aware.

For purposes of the Contract, the term "WHO Policies" means collectively: (i) the WHO Code of Ethics and Professional Conduct; (ii) the WHO Policy Directive on Protection from sexual exploitation and sexual abuse (SEA); (iii) the WHO Policy on Preventing and Addressing Abusive Conduct; (iv) the WHO Code of Conduct for responsible Research; (v) the WHO Policy on Whistleblowing and Protection Against Retaliation; (vi) the WHO Policy on Prevention, Detection and Response to Fraud and Corruption, and (vii) the UN Supplier Code of Conduct, in each case, as amended from time to time and which are publicly available on the WHO website at the following links: http://www.who.int/about/finances-accountability/procurement/en/ for the UN Supplier Code of Conduct and at http://www.who.int/about/ethics/en/ for the other WHO Policies.

- 2. Zero tolerance for sexual exploitation and abuse, sexual harassment and other types of abusive conduct. WHO has zero tolerance towards sexual exploitation and abuse, sexual harassment and other types of abusive conduct. In this regard, and without limiting any other provisions contained herein:
- (i) each legal entity Contractor warrants that it will: (i) take all reasonable and appropriate measures to prevent sexual exploitation or abuse as described in the WHO Policy Directive on Protection from sexual exploitation and sexual abuse (SEA), and/or sexual harassment and other types of abusive conduct as described in the WHO Policy on Preventing and Addressing Abusive Conduct by any of its employees and any other natural or legal persons engaged or otherwise utilized to perform the work under the Contract; and (ii) promptly report to WHO and respond to, in accordance with the terms of the respective Policies, any actual or suspected violations of either Policy of which the Contractor becomes aware; and
- (ii) each individual Contractor warrants that he/she will (i) not engage in any conduct that would constitute sexual exploitation or abuse as described in the WHO Policy Directive on Protection from sexual exploitation and sexual abuse (SEA), and/or sexual harassment and other types of abusive conduct as described in the WHO Policy on Preventing and Addressing Abusive Conduct. Without limiting the foregoing, the individual Contractor shall promptly report to WHO, in accordance with the terms of the respective Policies, any actual or suspected violations of either Policy of which the individual Contractor becomes aware.
- 3. <u>Tobacco/Arms Related Disclosure Statement</u>. The Contractor may be required to disclose relationships it may have with the tobacco and/or arms industry through completion of the WHO Tobacco/Arms Disclosure Statement. In the event WHO requires completion of this Statement, the Contractor undertakes not

to permit work on the Contract to commence, until WHO has assessed the disclosed information and confirmed to the Contractor in writing that the work can commence.

- 4. <u>Anti-Terrorism and UN Sanctions; Fraud and Corruption</u>. The Contractor warrants for the entire duration of the Contract that:
- i. it is not and shall not be involved in, or associated with, any person or entity associated with terrorism, as designated by any UN Security Council sanctions regime, that it shall not make any payment or provide any other support to any such person or entity and that it shall not enter into any employment or other contractual relationship with any such person or entity;
- ii. it shall not engage in any fraudulent or corrupt practices, as defined in the WHO Policy on Prevention, Detection and Response to Fraud and Corruption, in connection with the execution of the Contract;
- iii. it shall take all necessary measures to prevent the financing of terrorism and/or any fraudulent or corrupt practices as referred to above in connection with the execution of the Contract; and

Relevant information on the nature of any credible allegations of such actual or suspected violations, as well as the details of the intended response and the outcome of any such response, should be communicated and coordinated with WHO, with the understanding that, subject to the terms of the WHO Policy on Prevention, Detection and Response to Fraud and Corruption, confidentiality and the due process rights of those involved will be respected.

In the event that any resources, assets and/or funds provided to or acquired by the Contractor under the Contract are found to have been used by the Contractor, its employees or any other natural or legal persons engaged or otherwise utilized to perform any work under the Contract, to finance, support or conduct any terrorist activity or any fraudulent or corrupt practices, the Contractor shall promptly reimburse and indemnify WHO for such resources, assets and/or funds (including any liability arising from such use).

- 5. <u>Breach of essential terms</u>. The Contractor acknowledges and agrees that each of the provisions of paragraphs 1, 2, 3 and 4 above constitutes an essential term of the Contract, and that in case of breach of any of these provisions, WHO may, in its sole discretion, decide to:
- i. terminate the Contract, and/or any other contract concluded by WHO with the Contractor, immediately upon written notice to the Contractor, without any liability for termination charges or any other liability of any kind; and/or
- ii. exclude the Contractor from participating in any ongoing or future tenders and/or entering into any future contractual or collaborative relationships with WHO.

WHO shall be entitled to report any violation of such provisions to WHO's governing bodies, other UN agencies, and/or donors.

- 6. <u>Use of WHO Name and Emblem</u>. Without WHO's prior written approval, the Contractor shall not, in any statement or material of an advertising or promotional nature, refer to the Contract or the Contractor's relationship with WHO, or otherwise use the name (or any abbreviation thereof) and/or emblem of the World Health Organization.
- 7. Assurances regarding procurement. If the option for payment of a maximum amount applies, to the extent the Contractor is required to purchase any goods and/or services in connection with its performance of the Contract, the Contractor shall ensure that such goods and/or services shall be procured in accordance with the principle of best value for money. "Best value for money" means the responsive offer that is the best combination of technical specifications, quality and price.
- 8. <u>Audit and Investigations</u>. WHO may request a financial and operational review or audit of the work performed under the Contract, to be conducted by WHO and/or parties authorized by WHO, and the Contractor undertakes to facilitate such review or audit. This review or audit may be carried out at any time during the implementation of the work performed under the Contract, or within five years of completion of the work. In order to facilitate such financial and operational review or audit, the Contractor shall keep accurate and systematic accounts and records in respect of the work performed under the Contract. Similarly, WHO may initiate an investigation into credible allegations of fraud and corruption and other forms of misconduct based on information received in accordance with its respective policies, procedures and rules.

In this context, the Contractor shall make available, without restriction, to WHO and/or parties authorized by WHO:

- i. the Contractor's books, records and systems (including all relevant financial and operational information) relating to the Contract; and

- 8. The Contractor, its employees and any other persons and entities used by the Contractor shall not violate any intellectual property rights, confidentiality, right of privacy or other right of any person or entity whomsoever.
- 9. Except as otherwise explicitly provided in the Contract, the Contractor shall at all times provide all the necessary on-site and off-site resources to meet its obligations hereunder. The Contractor shall only use highly qualified staff, acceptable to WHO, to perform its obligations hereunder.
- 10. The Contractor shall take full and sole responsibility for the payment of all wages, benefits and monies due to all persons and entities used by it in connection with the implementation and execution of the Contract, including, but not limited to, the Contractor's employees, permitted subcontractors and suppliers.
- 11. Except as explicitly provided in the Contract, the Contractor shall keep confidential all information which comes to its knowledge during, or as a result of, the implementation and execution of the Contract. Accordingly, the Contractor shall not use or disclose such information for any purpose other than the performance of its obligations

under the Contract. The Contractor shall ensure that each of its employees and/or other persons and entities having access to such information shall be made aware of, and be bound by, the obligations of the Contractor under this paragraph. However, there shall be no obligation of confidentiality or restriction on use, where: (i) the information is publicly available, or becomes publicly available, otherwise than by any action or omission of the contractor, or (ii) the information was already known to the Contractor (as evidenced by its written records) prior to becoming known to the Contractor in the implementation and execution of the Contract; or (iii) the information was received by the Contractor from a third party not in breach of an obligation of confidentiality.

- 12. The Contractor, its employees and any other persons and entities used by the Contractor shall furthermore not copy and/or otherwise infringe on copyright of any document (whether machine-readable or not) to which the Contractor, its employees and any other persons and entities used by the Contractor have access in the performance of the Contract.
- 13. The Contractor may not communicate at any time to any other person, Government or authority external to WHO, any information known to it by reason of its association with WHO which has not been made public except with the authorization of WHO; nor shall the Contractor at any time use such information to private advantage.
